This agreement, entered between Coues Outfitters, LLC and the Client, sets forth the terms and conditions between the parties, and the services to be provided by Coues Outfitters. This agreement represents the final resolution of all previous discussions and negotiations, and there are no implied terms to this agreement other than those expressly set forth herein. The client acknowledges that he or she is purchasing a "fair chase" hunt in Sonora Mexico. As such, this contract or any articles herein do not guarantee or promise a successful hunt.

Hunt Information:

Location: Banamachi, Sonora, Mexico

Hunt Type: Gould's Turkey (Shotgun or Bow)

Type of Accommodations: Rustic ranch house

Dates: Arrive _____; Depart _____ (first or second week of May)

Hunt Duration: 3 days, 4 nights

Hunt includes:

- Transportation, via vehicle, to and from Tucson (or you can bring your own truck)
- Mexican hunting license and turkey tag
- Use of ranch 12 gauge shotguns, if you prefer not to bring your own shotgun
- Mexican gun permit processing at a cost of \$150 (up to 2 firearms per person)
- Trophy importation paper work for US
- Lodging
- Meals
- Drinks for the field
- Field preparation of meat and trophies

Hunt excludes:

- Taxidermy and delivery of trophy to a USDA approved facility
- Shipping of meat and trophies
- Alcoholic beverages (you can bring your own)

- Gratuities to ranch staff
- Accommodations and meals prior to Day 1 of hunt and after last day hunt

Cost & Payment Requirements:

Price: \$2200 US per hunter (2x1 guided); \$500 US non-hunter

Gun Permit: \$150 US

Deposits: \$1000 US due at contract signing

Payment Balance of \$1200 plus any gun permits due April 1st prior to start of hunt

In the case of cancellations, deposits will be refunded if notice is received prior to April 1st on the year of the hunt. Cancellations within 30 days of the hunt shall forfeit total hunt cost unless transferred to an acceptable substitute client. Payments may be made by personal or company check, payable to Coues Outfitters.

Client Responsibilities:

- Provide copy of valid Passport and Driver's License for hunting permits/licenses
- No undocumented/unpermitted firearms allowed in Mexico including handguns
- Conduct yourself in a responsible and conscientious manner at all times
- Practice firearm safety in and out of the field
- No consumption of alcohol during hunting hours, or possession of illegal drugs
- Observe all hunting regulations of Sonora, Mexico
- Client shall provide:
 - ✓ Sleeping bag
 - ✓ Bath towel
 - ✓ Personal items (soap, shampoo, etc)
 - ✓ Hunting weapons and ammo (unless prior arrangements have been made)
 - ✓ Helmet if desired for use on ATVs or horseback.
